In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:



4. The Corporation shall pay the Teacher for services under this Contract the total salary of **\$103,000.00** during the school year. Ind. Code 20-28-6-2(a) (3) (C)
5. The Corporation shall pay this amount in **24.0** installments on a **twice a month basis**. Ind. Code 20-28-6-2(a) (3) (D) Ind. Code 20-28-6-5(1)
6. This Contract may be cancelled during its term for any of the grounds set forth in Ind. Code 20-28-7.5-1(b) pursuant to the procedures set for in Ind. Code 20-28-7.5-2 and Ind. Code 20-28-7.5-3.
7. This Contract is a public record pursuant to Ind. Code 20-28-6-2(d) and Ind. Code 5-14-3.

**AMENDMENT TO SUPERINTENDENT’S CONTRACT**

Amendment made this 1st day of July, 2019, by and between the Board of Education of the Attica Consolidated School Corporation (hereinafter “Board”) and Sheri L Hardman (hereinafter “SUPERINTENDENT”).

**WITNESSETH**

WHEREAS, the parties have previously entered into an Agreement dated November 15, 2017, governing the employment of the Superintendent through June 30, 2021; and

WHEREAS, the parties now desire to amend the Agreement;

NOW, THEREFORE, in consideration of the mutual promises of the parties hereinafter contained and for other good and valuable consideration, the parties agree as follows:

1. **Compensation- Paragraph 5(a)-** Delete and substitute: "For the period January 3, 2018 through June 30, 2019, the annual salary shall be One Hundred Thousand (\$100,000) Dollars. For the period July 1, 2019 through June 30, 2021, the annual salary shall be One Hundred Three Thousand (\$103,000) Dollars"



- 2) Employee shall be paid: \$77,403. Employer contribution 3% gross to a retirement plan of \$2,322.09; Paid Family Insurance except for \$1.00 per year.
- 3) Employment At Will. The School Corporation agrees to continue to engage Employee to serve the School Corporation as the Interim Jr. Sr. High School Principal in exchange for the Employee's agreement to fulfill the promises set forth in this Agreement. Employee shall perform all duties as assigned by the Superintendent. The parties agree that the Employee shall be an employee at will and that either party may terminate the employment relationship at any time with or without cause and with or without notice.
- 4) In addition to the compensation specified above, the employee shall be entitled to 10 sick days per year accumulating to 120 and 3 personal days.






